



LIST OF SUPPORTING DOCUMENTS **SENARAI DOKUMEN SOKONGAN**

1. Identity card of husband and wife (original and photocopy).
Kad pengenalan suami dan isteri (asal dan salinan).
2. Passport of husband and wife, if any of them is a foreigner (original and photocopy).
Paspot suami dan isteri, jika salah seorang mereka orang asing (asal dan salinan).
3. Identity card of father of husband and wife (photocopy).
Kad pengenalan bapa kepada suami dan isteri (salinan).
4. Identify card of all witness to the marriage (photocopy).
Kad pengenalan semua saksi kepada perkahwinan (salinan).
5. Explanation letter to the Registrar General of Marriages on why one party is unable to attend the proceeding (if applicable). Please state the reason on the Declaration Form as well.
Surat kepada Ketua Pendaftar Perkahwinan yang menjelaskan sebab pasangan tidak dapat menghadiri prosiding (jika berkenaan). Sila nyatakan sebab tersebut ke dalam Borang Deklarasi.
6. If the wife is below 18 years of age at the time of marriage, a letter from the parents or guardian of the wife to state that they consented to the marriage.
Jika pemohon (isteri) dibawah umur 18 tahun semasa berkahwin, surat dari ibubapa atau penjaga pemohon yang menyatakan persetujuan mereka terhadap perkahwinan tersebut.
7. Death certificate of husband from previous marriage (if applicable).
Sijil Kematian suami dari perkahwinan terdahulu (jika berkenaan).
8. Divorce certificate of wife from previous marriage (if applicable).
Surat Cerai isteri dari perkahwinan terdahulu (jika berkenaan).
9. Statutory declaration from penghulu/head village/head longhouse village/other competent authority (if applicable). Example: Declaration that the customary marriage was conducted or that the wife has been lawfully divorced from her living ex-husband. Please state the name and identity card no. of all the witness to the marriage.
Surat sumpah dari penghulu/ketua kampung/Tuai rumah panjang/pihak berkuasa yang berkelayakan lain (jika berkenaan). Seperti: Deklarasi bahawa perkahwinan adat telah dijalankan atau bahawa pemohon (isteri) telah bercerai secara sah dari suaminya yang terdahulu. Nama dan bilangan kad pengenalan saksi hendaklah disebut dalam surat sumpah berkenaan.

10. Marriage certificate issued by competent authority in foreign state if the marriage was contracted abroad.

Sijil kahwin yang dikeluarkan oleh pihak berkuasa luar negeri sekiranya pasangan berkahwin di luar negeri.

11. Translation of any document which is printed in a language other than in English or Malay.
