TABUNG AMANAH PEKERJA ACT (CHAPTER 167)

TABUNG AMANAH PEKERJA (AMENDMENT) RULES, 2013

In exercise of the power conferred by section 38(2) of the Tabung Amanah Pekerja Act, the Lembaga Tabung Amanah Pekerja hereby makes the following Rules —

Citation.

1. These Rules may be cited as the Tabung Amanah Pekerja (Amendment) Rules, 2013.

Amendment of rule 2 of S 10/1999.

- 2. Rule 2 of the Tabung Amanah Pekerja Rules, in these Rules referred to as the principal Rules, is amended
 - (a) in sub-rule (1), by deleting "(1)" from the first line;
 - (b) by repealing sub-rule (2).

Amendment of rule 3.

3. Rule 3 of the principal Rules is amended, in sub-rule (1) by deleting "Form TAP 01" from the last line and by substituting "in such form and manner as the Board may determine" therefor.

Amendment of rule 7.

4. Rule 7 of the principal Rules is amended by deleting "in Form TAP 03" and by substituting "made in such form and manner as the Board may determine" therefor.

Amendment of rule 8.

5. Rule 8 of the principal Rules is amended by deleting "Form TAP 05" from the penultimate line and by substituting "such form and manner as the Board may determine" therefor.

Amendment of rule 10.

6. Rule 10 of the principal Rules is amended, in sub-rule (1), by deleting "Form TAP 02" from the last line and by substituting "form as the Board may determine" therefor.

Substitution of rule 18.

7. Rule 18 of the principal Rules is repealed and the following new rule substituted therefor —

"Withdrawal forms.

18. All applications for withdrawals under section 17 shall be made using such forms as the Board may determine.".

Substitution of rule 19.

8. Rule 19 of the principal Rules is repealed and the following new rule substituted therefor -

"Withdrawals under section 11.

19. All applications for refunds under section 11 shall be made using such forms as the Board may determine.".

Repeal of rule 27.

9. Rule 27 of the principal Rules is repealed.

Repeal of Schedule.

10. The Schedule to the principal Rules is repealed.
