CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2011/2012) (NO. 9) ORDER, 2013

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 48/2011) dated the 9th day of August 2011 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam.

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest.

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service.

AND WHEREAS the sum of five thousand one hundred and thirty million, seven hundred and eighty-five thousand and six hundred dollars (\$5,130,785,600.00) has been provided by the Supply (2011/2012) Act, 2011 (Act 1 of 2011).

AND WHEREAS the sum of nineteen million, five hundred thousand, nine hundred and twenty-eight dollars (\$19,500,928.00) has been provided by the Supplementary Supply (2011/2012) (No. 1) Order, 2011 (S 81/2011).

AND WHEREAS the sum of twenty-eight million, one hundred and eighteen thousand, six hundred and fifty-nine dollars and seventy-six cents (\$28,118,659.76) has been provided by the Supplementary Supply (2011/2012) (No. 2) Order, 2012 (S 2/2012).

AND WHEREAS the sum of four million, two hundred and ninety-one thousand, one hundred and two dollars and twenty-nine cents (\$4,291,102.29) has been provided by the Supplementary Supply (2011/2012) (No. 3) Order, 2012 (S 8/2012).

AND WHEREAS the sum of forty-eight million, eight hundred and thirty-eight thousand, seven hundred and forty-three dollars (\$48,838,743.00) has been provided by the Supplementary Supply (2011/2012) (No. 4) Order, 2012 (S 9/2012).

AND WHEREAS the sum of seven million, eight hundred and twenty-three thousand, six hundred and twelve dollars and forty-two cents (\$7,823,612.42) has

been provided by the Supplementary Supply (2011/2012) (No. 5) Order, 2012 (S 41/2012).

AND WHEREAS the sum of ninety-four million, four hundred and seventy-eight thousand, four hundred and eighty-two dollars (\$94,478,482.00) has been provided by the Supplementary Supply (2011/2012) (No. 6) Order, 2012 (S 42/2012).

AND WHEREAS the sum of fifteen million, nine hundred and ninety-four thousand, eight hundred and ten dollars and thirty-two cents (\$15,994,810.32) has been provided by the Supplementary Supply (2011/2012) (No. 7) Order, 2012 (S 49/2012).

AND WHEREAS the sum of nineteen million, six hundred and sixty-nine thousand, seven hundred and eighty-six dollars and eighty-one cents (\$19,669,786.81) has been provided by the Supplementary Supply (2011/2012) (No. 8) Order, 2012 (S 50/2012).

AND WHEREAS it is now requisite to make a further provision of seventy million, seven hundred and fifty-five thousand, two hundred and forty-three dollars and forty-four cents (\$70,755,243.44).

NOW, THEREFORE, in the exercise of the powers conferred by Article 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2011/2012) (No. 9) Order, 2013.

Further expenditure for year 2011/2012 and appropriation.

2. (1) The issue of a sum not exceeding seventy million, seven hundred and fifty-five thousand, two hundred and forty-three dollars and forty-four cents (\$70,755,243.44) out of the Consolidated Fund for expenditure on the services specified in the second column of the Schedule for the year 2011/2012, not provided or not fully provided for by the Supply (2011/2012) Act, 2011 (Act 1 of 2011), the Supplementary Supply (2011/2012) (No. 1) Order, 2011 (S 81/2011), the Supplementary Supply (2011/2012) (No. 2) Order, 2012 (S 2/2012), the Supplementary Supply (2011/2012) (No. 3) Order, 2012 (S 8/2012), the Supplementary Supply (2011/2012) (No. 4) Order, 2012 (S 9/2012), the Supplementary Supply (2011/2012) (No. 5) Order, 2012 (S 41/2012), the Supplementary Supply (2011/2012) (No. 6) Order, 2012 (S 42/2012), the Supplementary Supply (2011/2012) (No. 7) Order, 2012 (S 49/2012) and the Supplementary Supply (2011/2012) (No. 8) Order, 2012 (S 50/2012) is hereby authorised.
