CONSTITUTION OF BRUNEI DARUSSALAM (Order made under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2012/2013) (NO. 4) ORDER, 2013

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 48/2011) dated the 9th day of August 2011 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam.

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers designable in the public interest.

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service.

AND WHEREAS it is provided by section 10(3) of the Constitution (Financial Procedure) Order that His Majesty the Sultan and Yang Di-Pertuan may, if he is satisfied that there has arisen an urgent and unforeseen need for expenditure for which no other provision exists and for which funds cannot be provided under section 13(4) of the Constitution (Financial Procedure) Order, make advances from the Contingencies Fund to meet that need.

AND WHEREAS the sum of five thousand, two hundred and thirty million, seven hundred and eighty-five thousand dollars (\$5,230,785,000.00) has been provided by the Supply (2012/2013) Act, 2012 (Act 1 of 2012).

AND WHEREAS the sum of one hundred and fifty-five million, two hundred and ninety-six thousand and five hundred dollars [\$155,296,500.00] has been provided by the Supplementary Supply (2012/2013) (No. 1) Order, 2013 (S 4/2013).

AND WHEREAS the sum of seven million, four hundred and fifty-six thousand, seven hundred and sixty-seven dollars (\$7,456,767.00) has been provided by the Supplementary Supply (2012/2013) (No. 2) Order, 2013 (\$5/2013).

AND WHEREAS the sum of forty-one million, eight hundred and fifty-six thousand, two hundred and twenty-five dollars (\$41,856,225.00) has been provided by the Supplementary Supply (2012/2013) (No. 3) Order, 2013.

AND WHEREAS it is now requisite to make a further provision of twenty-nine million, one hundred and sixty-four thousand, twenty-three dollars and forty-three cents (\$29,164,023.43).

NOW, THEREFORE, in the exercise of the powers conferred by Article 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2012/2013) (No. 4) Order, 2013.

Further expenditure for year 2012/2013, appropriation and replacement of sum advanced from Contingencies Fund.

- 2. (1) The issue of a sum not exceeding twenty-nine million, one hundred and sixty-four thousand, twenty-three dollars and forty-three cents (\$29,164,023.43) out of the Consolidated Fund for expenditure on the services specified in the second column of the Schedule for the year 2012/2013, not provided or not fully provided for by the Supply (2012/2013) Act, 2012 (Act 1 of 2012), the Supplementary Supply (2012/2013) (No. 1) Order, 2013 (S 4/2013), the Supplementary Supply (2012/2013) (No. 2) Order, 2013 (S 5/2013) and the Supplementary Supply (2012/2013) (No. 3) Order, 2013 is hereby authorised.
- (2) For the purposes of subsection (1), the sum specified in the third column of the Schedule is appropriated to the head of expenditure specified in the first column thereto.
- (3) The replacement of such sum with the sum specified in the fourth column of the Schedule, being the sum advanced from the Contingencies Fund, is hereby authorised.
