Commencement: 27th March 1992 [S 7/92]

#### Citation.

1. These Rules may be cited as the Magistrates' Courts (Court Fees and Costs) Rules.

#### Application.

**2.** These Rules shall apply to any proceedings begun in a Magistrates' Court on or after the 27th day of March, 1992.

#### Fees.

**3.** The fees and costs set out in the Schedule shall be payable in all proceedings in the Magistrates' Court.

#### Costs.

4. (1) Subject to sub-rule (2), there shall be no award of fees or costs to a party, other than those set out in the Schedule.

(2) Notwithstanding sub-rule (1) if, before the claim is served, there is an agreement by the party to a contrary effect, the Court may order that the party shall pay the agreed sum, less any amount ordered by the Court under the Schedule.
