PORTS ACT (CHAPTER 144) (Section 13(1))

Ports (Dues and Rates) (Amendment) Notification 1989

In exercise of the powers conferred by Section 13(1) of the Ports Act (Chapter 144) the Minister of Communications with the approval of His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam, hereby makes the following Notification:—

1. This Notification may be cited as the Ports (Dues and Rates) (Amendment) Notification 1989 and shall be deemed to have come into force on the 1st. day of December, 1988.

Citation and commencement.

2. The Schedule to the Ports (Dues and Rates) Notification 1986 is hereby amended -

Amendment of Schedule.

(1) by deleting item 2 of Part II and substituting therefor the following provisions:—

"2. Storage

4th week and subsequent weeks	Additional \$15.00

Note:

- 1. Storage period starts from midnight after completion of discharge, delivery to storage or unstuffing from containers.
- 2. A Friday, Sunday or holiday falling within the 2 days free period will count as an additional free day provided the cargo is removed within the free period. Storage will be levied for these days after the free period has expired.
- 3. The rates will apply to import, export, shut out, over landed containerised and refrigerated transhipment cargoes.
- 4. Non refrigerated transhipment cargoes will receive 14 days free storage after which the above storage will apply Fridays, Sundays and Holidays will not count as additional free storage days.
- 5. Import cargoes must have status changed within the 2 days free period to qualify for transhipment cargo storage if reexported.
- 6. Cargoes or containers stored over 42 days in the port are liable to be disposed off by public auction or tender".
- (2) by adding after item 7 of Part IV the following provisions:—
- ''8. The cost of storing or using transportation and equipment for loading within the Ports Area.

a)	Lorry, Van and Pick-up	\$2.00 each a day or part of a day or \$40.00 each a month.
b	Trailer	\$5.00 each a day or part of a day or \$100.00 each a month.
c)	Forklift that can lift up to 4 tons	\$3.50 each a day or part of a day or \$35.00 each a month.
d)	Crane that can lift up to 75 tons	\$50.00 each a day or part of a day or \$500.00 each a month.
e)	Other items (such as empty palletes) and loading equipment	\$1.00 each a month for 0.09 square metre or \$0.10 a day.

Note: A day will be counted as starting 7.00 a.m to 7.00 a.m. the next day".
