MISCELLANEOUS LICENCES ACT
(CHAPTER 127)

MISCELLANEOUS LICENCES (AMENDMENT) REGULATIONS, 2006

In exercise of the power conferred by subsection (1) of section 2 of the Miscellaneous Licences Act, His Majesty the Sultan and Yang Di-Pertuan in Council hereby makes the following Regulations —

Citation.

1. These Regulations may be cited as the Miscellaneous Licences (Amendment) Regulations, 2006.

Amendment of regulation 6 of S 31/82.

2. Regulation 6 of the Miscellaneous Licences Regulations, in these Regulations referred to as the principal Regulations, is amended by deleting "annual" from the second line.

Amendment of regulation 7.

3. Regulation 7 of the principal Regulations is amended by deleting "a period of 12 months from the date of issue" and by substituting "such period of one, 2, 3, 4 or 5 years from the date of issue as the licensing authority shall determine when it is issued" therefor.

Amendment of First Schedule.

4. The First Schedule to the principal Regulations is amended, in the first column, by deleting "The Brunei Economic Development Board" and by substituting "The Promotion and Entrepreneurial Development Division of the Ministry of Industry and Primary Resources" therefor.

Amendment of Second Schedule.

5. The Second Schedule to the principal Regulations is amended, in paragraph 7(a), by deleting "an annual" and by substituting "a" therefor;

Substitution of Fourth Schedule.

6. The Fourth Schedule to the principal Regulations is repealed and substituted by the following new Schedule —
