# MUNICIPAL BOARDS ACT (CHAPTER 57)

## MUNICIPAL (AMENDMENT) BY-LAWS, 2006

In exercise of the power conferred by section 5 of the Municipal Boards Act, the Bandar Seri Begawan Municipal Board hereby passes the following By-Laws —

#### Citation and commencement.

1. These By-Laws may be cited as the Municipal (Amendment) By-Laws, 2006 and shall commence on the 1st. June, 2006.

# Amendment of By-Laws.

2. The By-Laws passed by the Brunei Sanitary Board to have effect from the 1st. January, 1922, in these By-Laws referred to as the principal By-Laws, are amended by deleting ", Swine" from the heading immediately before by-law 57.

#### Amendment of by-law 57.

- 3. By-law 57 of the principal By-Laws is amended
  - (a) by deleting "pigsties" from the marginal note;
  - (b) by deleting "pigsty" from the fourth line;
- (c) by deleting "renewable annually" from the eighth line and by substituting "renewed every one, 2, 3, 4 or 5 years as the licensing authority shall determine when it is issued" therefor;
  - (d) by deleting "pigs" from the tenth line;
- (e) by deleting "No fee shall be charged for any such licence" from the last line and by substituting "Such licence shall be issued upon payment of the fee specified in the Schedule" therefor.

#### Amendment of by-law 58.

4. By-law 58 of the principal By-Laws is amended by deleting "pigsty" from the second line.

#### Amendment of by-law 59.

5. By-law 59 of the principal By-Laws is amended by deleting "pigsty" from the second line.

# Amendment of by-law 60.

- 6. By-law 60 of the principal By-Laws is amended by repealing paragraph (ii) and by substituting the following new paragraph therefor
  - '(ii) Such licence shall be issued upon payment of the fee specified in the Schedule.".

# Amendment of by-law 63.

- 7. By-law 63 of the principal By-Laws is amended by adding the following new paragraph
  - "(iii) A licence under paragraph (i) shall be issued upon payment of the fee specified in the Schedule.".

#### Repeal of by-laws 86 to 104.

8. The heading "The Establishment and Regulation of Slaughter-houses" appearing immediately before by-law 86 and by-laws 86, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 101, 102, 103 and 104 of the principal By-Laws are repealed.

#### Amendment of by-law 105.

9. By-law 105 of the principal By-Laws is amended by deleting "may be issued free of charge" from the last line and by substituting "shall be issued upon payment of the fee specified in the Schedule" therefor.

#### Amendment of by-law 117.

10. By-law 117 of the principal By-Laws is amended, in paragraph (i), by deleting "may be issued free of charge and every such licence shall expire on the thirty-first day of December on the year in which it is issued." from the fifth to eighth lines and by substituting "shall be issued upon payment of the fee specified in the Schedule." therefor.

## Amendment of by-law 124.

11. By-law 124 of the principal By-Laws is amended, in paragraph (i), by deleting "renewable annually and may be issued free of charge" from the last 2 lines and by substituting "renewed every one, 2, 3, 4 or 5 years as the licensing authority shall determine when it is issued and shall be issued upon payment of the fee specified in the Schedule" therefor.

#### Amendment of by-law 129.

- 12. By-law 129 of the principal By-Laws is amended -
- (a) in paragraph (i), by deleting "for which a fee may be charged not less than one and not exceeding ten dollars per month" from the second, third and fourth last lines and by substituting "and such licence shall be issued upon payment of the fee specified in the Schedule";
- (b) also in paragraph (i), by deleting "on" from the last line and by substituting "an" therefor.

#### Further amendment of By-Laws.

13. The principal By-Laws are amended by deleting ", Native Inns" from the heading immediately before by-law 135.

# Amendment of by-law 136.

- 14. By-law 136 of the principal By-Laws is amended by repealing paragraph (ii) and by substituting the following new paragraph therefor
  - "(ii) Such licence shall be issued upon payment of the fee specified in the Schedule.".

## Amendment of by-law 140.

- 15. By-law 140 of the principal By-Laws is amended —
- (a) by deleting "Inns, eating" from the marginal note and by substituting "Eating" therefor;
  - (b) by deleting "native inn" from the first 2 lines;
- (c) by deleting "may be issued free" from the last line and by substituting "shall be issued upon payment of the fee specified in the Schedule" therefor.

#### Amendment of by-law 141.

16. By-law 141 of the principal By-laws is amended by deleting "native inn" from the first line.

# Repeal of by-laws 142 to 145.

17. By-laws 142, 143, 144 and 145 of the principal By-Laws are repealed.

# Amendment of by-law 166.

- 18. By-law 166 of the principal By-Laws is amended
  - (a) by repealing paragraph (j);
- (b) by deleting "renewable annually, and a fee to be approved by the Minister, which shall not exceed ten dollars for each year, may be charged therefor" from the last 3 lines and by substituting "issued upon payment of the fee specified in the Schedule" therefor.

19. The principal By-Laws are amended by adding the following new Schedule -
