MISCELLANEOUS LICENCES ACT  
(CHAPTER 127)

MISCELLANEOUS LICENCES (AMENDMENT) REGULATIONS, 2014

In exercise of the power conferred by section 2(1) of the Miscellaneous Licences Act, the Minister of Home Affairs, with the approval of His Majesty the Sultan and Yang Di-Pertuan, hereby makes the following Regulations —

**Citation and commencement.**

1. These Regulations may be cited as the Miscellaneous Licences (Amendment) Regulations, 2014 and shall commence on 1st January 2015.

**Amendment of regulation 1 of Miscellaneous Licences Regulations in Chapter 127.**

2. The Miscellaneous Licences Regulations, in these Regulations referred to as the principal Regulations, are amended, in regulation 1, by deleting “Miscellaneous” from the first line and by substituting “Business” therefor.

**Amendment of regulation 2.**

3. Regulation 2 of the principal Regulations is amended —

- (a) by deleting the definition of “authorised officer”;
- (b) by deleting the definition of “District Licensing Board”;
- (c) by deleting the definition of “licence”;
- (d) by deleting the definition of “licensing area”;
- (e) by deleting the definition of “licensing authority”.

**Substitution of regulation 5.**

4. Regulation 5 of the principal Regulations is repealed and the following new regulation is substituted therefor —

**“Form and conditions of licence.**

5. A licence shall be in such form and subject to such conditions as may be determined by the licensing authority.”.

**Amendment of regulation 6.**

5. Regulation 6 of the principal Regulations is amended by deleting “Fourth” from the second line.

**Substitution of regulation 8B.**

6. Regulation 8B of the principal Regulations is repealed and the following new regulation is substituted therefor —

**“Changes in particulars of licence.**

8B. Whenever any change is made or occurs to the name or address of the licenced place, the licensee shall, within 30 days of such change —

(a) furnish to the licensing authority a statement in writing specifying the nature and date of the change; and

(b) surrender the licence to the licensing authority,

and the licensing authority shall, as soon as practicable, issue a new licence to the licensee.”.

**Insertion of new regulation 8C.**

7. The principal Regulations are amended by inserting the following new regulation immediately after regulation 8B —

**“Replacement of lost or defaced licence.**

8C. (1) Where it is proved to the satisfaction of the licensing authority that a licence has been lost, destroyed or so mutilated or defaced as to be illegible, the licensing authority may, on receipt of an application from the licensee and on payment of a fee of \$2, issue a replacement licence to the licensee, and the replacement licence so issued shall have the same effect as the original.

(2) If at any time after the issue of a replacement licence the original licence is found, the licensee shall return the original licence to the licencing authority.”.

**Amendment of regulation 17A.**

8. Regulation 17A of the principal Regulations is amended, in sub-regulation (1), by deleting “the Chairman of” from the second line.

**Amendment of regulation 41.**

9. Regulation 41 of the principal Regulations is amended by deleting “In a licensing area the Chairman or any member of the licensing authority of that area” from the first two lines and by substituting “The licensing authority” therefor.

**Amendment of regulation 42.**

10. Regulation 42 of the principal Regulations is amended, in paragraph (a), by deleting “the Chairman of” from the third line.

**Amendment of regulation 42A.**

11. Regulation 42A of the principal Regulations is amended, in sub-regulation (1) —

(a) by deleting “the Chairman of” from the first line;

(b) by deleting “Chairman” from the last line and by substituting “licensing authority” therefor.

**Amendment of regulation 42B.**

12. Regulation 42B of the principal Regulations is amended, in sub-regulation (1) —

(a) in paragraph (a)(i) —

(i) by deleting “the Chairman of” from the first line;

(ii) by deleting “Chairman” from the fourth line and by substituting “licensing authority” therefor;

(b) in paragraph (b) —

(i) by deleting “the Chairman of” from the first line;

(ii) by deleting “Chairman” from the fourth line and by substituting “licensing authority” therefor;

(c) in paragraph (c) —

(i) by deleting “the Chairman of” from the first line;

(ii) by deleting “Chairman” from the second line and by substituting “licensing authority” therefor.

**Repeal of regulation 43.**

13. Regulation 43 of the principal Regulations is repealed.

**Repeal of regulation 44.**

14. Regulation 44 of the principal Regulations is repealed.

**Repeal of regulation 45.**

15. Regulation 45 of the principal Regulations is repealed.

**Repeal of First Schedule.**

16. The First Schedule to the principal Regulations is repealed.

**Repeal of Third Schedule.**

17. The Third Schedule to the principal Regulations is repealed.

**Amendment of Fourth Schedule.**

18. The Fourth Schedule to the principal Regulations is amended, in the heading, by deleting "FOURTH".
