TELECOMMUNICATIONS (RADIO-COMMUNICATION) (AMENDMENT) REGULATIONS, 2022

In exercise of the power conferred by section 77 of the Telecommunications Order, 2001, the Authority for Info-communications Technology Industry of Brunei Darussalam, with the approval of the Minister of Transport and Infocommunications, hereby makes the following Regulations —

Citation

1. These Regulations may be cited as the Telecommunications (Radio-communication) (Amendment) Regulations, 2022.

Amendment of regulation 11 of S 86/2013

- 2. Regulation 11 of the Telecommunications (Radio-communication) Regulations, 2013, in these Regulations referred to as the principal Regulations, is amended, in sub-regulation (4) —
- (a) by deleting paragraph (a) and by substituting the following new paragraph therefor
 - "(a) the prices as specified in Part VI of the Schedule;";
- (b) by inserting the following new paragraph immediately after paragraph (a) -
 - "(aa) the way in which prices are to be negotiated;".

Amendment of Schedule

- 3. The Schedule to the principal Regulations is amended -
- (a) in Part III, by repealing Division 1 and by substituting the following new Division therefor —

"PART III

ANNUAL FEES FOR USE OF RADIO FREQUENCY

Division 1

Broadcasting, cellular, land mobile or trunked radio wireless broadband access

The annual fee for radio frequency spectrum will be calculated using the following formula -
