1. This order may be cited as the Diplomatic Privileges (Food Citation. and Agriculture Organisation) Order.

THE ORGANISATION

2. The Food and Agriculture Organisation (hereinafter referred to as "the Organisation") is an organisation of which Her Britannic Majesty's Government in the United Kingdom and the governments of foreign sovereign Powers are members.

3. The Organisation shall have the legal capacity of a body corporate and, except in so far as in any particular case it has expressly waived its immunity, immunity from suit and legal process. No waiver of immunity shall be deemed to extend to any measure of execution.

Organisation to be body corporate.

4. The Organisation shall have the like inviolability of official archives and premises occupied as offices as is accorded in respect of official archives and premises of an envoy of a foreign sovereign Power accredited to Her Britannic Majesty.

Organisation to have same inviolability as envoys of accredited foreign sovereign Powers.

5. The Organisation shall have the like exemption or relief Organisation from taxes and rates, other than taxes on the importation of goods, as is accorded to a foreign sovereign Power.

to have same exemption from taxes and rates as foreign sovereign Powers.

6. The Organisation shall have exemption from taxes on the importation of goods directly imported by the Organisation for its official use in the State or for exportation, or on the importation of any of the publications of the Organisation directly imported by it, such exemption to be subject to compliance with such conditions as the Controller of Customs may prescribe for the protection of the revenue.

Organisation to have same exemption from customs duties on goods imported for its official use and on its official publications.

7. The Organisation shall have exemption from prohibitions and restrictions on importation or exportation in the case of goods directly imported or exported by the Organisation for its official use and in the case of any publications of the Organisation directly imported or exported by it.

Organisation to have exemption from restrictions on import and export in case of goods required for for its official use or in case of its official publications.

8. The Organisation shall have the right to avail itself, for Organisation telegraphic communications sent by it and containing only matter may send intended for publication by the press or for broadcasting (including press rates.

communications addressed to or despatched from places outside the State), of any reduced rates applicable for the corresponding service in the case of press telegrams.

REPRESENTATIVES OF MEMBERS: CHAIRMAN OF THE COUNCIL OF THE ORGANISATION

- 9.—(1) Except in so far as any privilege or immunity is immunities of waived, in the case of representatives of member governments, by the governments whom they represent and, in the case of the Chairman of the Council of the Organisation, by the Council of the Food and Agriculture Organisation, representatives of member governments and the Chairman of the Council of the Organisation shall enjoy-
 - (a) while exercising their functions as such, and during their journey to and from the place of meeting, immunity from personal arrest or detention and from seizure of their personal baggage and inviolability for all papers and documents:
 - (b) immunity from legal process of every kind in respect of words spoken or written and all acts done by them in their capacity as representatives; and
 - (c) while exercising their functions and during their journey to and from the place of meeting, the like exemption or relief from taxes as is accorded to an envoy of a foreign sovereign Power accredited to Her Britannic Majesty, save that the relief allowed, shall not include relief from customs and excise duties except in respect of goods imported as part of their personal baggage. They shall not, where the incidence of any form of taxation depends upon residence, be deemed to be resident in the State during any period when they are present in the State while exercising their functions and during their journey to and from the place of meeting.

The provisions of this paragraph shall not apply to British subjects whose usual place of abode is in the State.

- (2) For the purposes of the application of this order, the expression "representatives of member governments" shall be deemed to include their official staffs, accompanying them as such representatives, as delegates, deputy delegates, advisers, technical experts or secretaries of delegations.
- (3) The provisions of the preceding paragraphs of this article shall not confer immunity or privilege upon any person as the representative of Her Britannic Majesty's Government in the State or as a member of the staff of such a representative, or any person who is a British subject and who is not the representative of a Government of Her Britannic Majesty other than Her Britannic Majesty's Government in the State or a member of the staff of and accompanying any such representative.

HIGH OFFICIALS

10. Except in so far as in any particular case any privilege Privileges and or immunity is waived by the Organisation, officers of the Organisation holding the offices of Director-General and Deputy Director-General shall be accorded in respect of themselves, their spouses Organisation. and children under the age of twenty-one, the like immunity from suit and legal process, the like inviolability of residence and the like exemption or relief from taxes as is accorded to an envoy of a foreign sovereign Power accredited to Her Britannic Majesty, his spouse and children, including exemption from income tax in respect of emoluments received by them as officers of the Organisation.

PERSONS EMPLOYED ON MISSIONS ON BEHALF OF THE **ORGANISATION**

- 11. Except in so far as in any particular case any privilege Privileges and or immunity is waived by the Organisation, persons (other than officials of the Organisation) serving on committees of, or on behalf of the Organisation shall enjoy-
 - (a) while exercising their functions as such, and during their journey to and from the place of meeting, immunity from personal arrest or detention and from seizure of their personal baggage and inviolability for all papers and documents relating to the work of the Organisation; and
 - (b) immunity from legal process of every kind in respect of words spoken or written and all acts done by them in the exercise of their functions. Such immunity shall continue notwithstanding that the persons concerned are no longer employed on missions on behalf of the Organisation.

OTHER OFFICIALS OF THE ORGANISATION

12. Except in so far as in any particular case any privilege Privileges and or immunity is waived by the Organisation, all officials of the immunities of Organisation, other than those referred to in article 10, shall of the enjoy-

- (a) immunity from suit and legal process in respect of words spoken or written and all acts done by them in the course of the performance of their official duties; and
- (b) exemption from income tax in respect of emoluments received by them as officers or servants of the Organisation.
