ROAD TRAFFIC (EXEMPTION) ORDER

*Commencement: 1st January 1956***Citation**

1. This Order may be cited as the Road Traffic (Exemption) Order.

Exemptions

2. The persons and authorities specified in the first column of the Schedule are exempted from such of the provisions of the Act and the regulations made thereunder as are specified in the second column of the Schedule in respect of the vehicles or class or description of vehicles specified in the third column of the Schedule subject to the conditions set out in the fourth column of the Schedule.

Licences of persons and vehicles exempted from payment of fees to be indorsed accordingly

3. The driving licence of every person exempted by this Order, from the payment of fees for a driving licence and the licence of every motor vehicle and trailer in respect of which the payment of licence fees has been exempted by this Order, shall be indorsed with the words "Exempted no fee payable".
