#### ROAD TRAFFIC (KUALA BELAIT AND SERIA MUNICIPAL BOARD) (BUS AND TAXI STANDS) RULES

Commencement: 29th Febuary 1964

#### Citation and application

**1.** These Rules may be cited as the Road Traffic (Kuala Belait and Seria Municipal Board) (Bus and Taxi Stands) Rules and shall apply to the Kuala Belait and Seria Municipal Area.

#### Interpretation

2. In these Rules —

"goods vehicle" means a motor vehicle ordinarily used for the carriage of goods for hire or reward;

"park" means to stop a vehicle but does not include stopping only for such time as is reasonably necessary to take up or set down passengers or load or unload goods, or stopping in obedience to traffic signs or signals or in case of accident or to avoid accident or involuntary stopping;

"parking place" means any part of a road in which the appropriate sign under the Road Traffic Regulations (Rg 1) indicates that parking is permitted or any part of the road which is indicated by a Municipal notice as taxi stand and bus stand;

"sign" means a sign under the Road Traffic Regulations (Rg 1).

#### Parking forbidden if obstruction caused

**3.** No vehicle shall be so parked on the road that it forms an obstruction to the free passage of vehicular traffic or pedestrians.

#### **Parking of vehicles**

4. No taxi cab, motor bus or goods vehicles shall be parked on any road within the shopping area of Kuala Belait and Seria except in a parking place where the Municipal notice indicates that a taxi cab, motor bus or goods vehicle may be parked there.

#### [Subsidiary]

#### Permitted parking place

**5.** The places described in column 2 of the first and second parts of the Schedule shall be places within the Kuala Belait and Seria Municipal limits where the parking of the vehicles described in column 3 of the Schedule is permitted.

### No parking

**6.** No vehicle shall be parked on any road or part of the road where a sign indicates that parking is prohibited.

### **Parking place**

7. (1) The Kuala Belait and Seria Municipal Board, with the approval of the Commissioner of Police, may place a notice indicating the type or class or description of vehicles to be parked on any part of a road which may be prescribed in a notice published in the *Gazette*.

(2) No vehicle shall be parked where the Municipal notice indicates that the parking place is for the use of a certain class or description of vehicles unless that vehicle belongs to that class or description.

(3) Where, in any parking place, individual places are demarcated by lines painted on the road, no vehicle shall be parked except within those lines.

(4) Where a parking place is designed for the accommodation of taxi cab in file, every taxi cab parking there shall park at the rear of the file and shall close up as the other taxi cab ahead moves off.

(5) No driver of a taxi cab shall in any manner interfere with, molest or prevent the driver of another taxi cab from stationing his taxi cab in a parking place.

#### Non-demarcated parking place

8. Where there is no demarcated parking place on a road —

(a) four wheeled vehicles shall be parked with the near side or off side wheels, as the case may be, not more than  $1\frac{1}{2}$  feet away from the kerb or drain;

(b) where no parking island or parking space is provided for, three wheeled vehicle shall be parked with one of the wheels parallel to the kerb or drain and not more than one foot away therefrom;

(c) two wheeled motorcycles or bicycles shall be parked parallel to the kerb or drain and with their wheels not more than  $1\frac{1}{2}$  feet away therefrom.

## Washing and repairing of vehicle in parking place prohibited

9. No person shall in any parking place wash or repair any vehicle.

### **Touting prohibited**

**10.** No person or a driver of a taxi cab or an omnibus shall at any time, whether his vehicle is being parked in any parking place or plying for hire, employ, use or avail himself of the service of any person in the capacity of a tout or permit any person to tout for him.

### Plying for passengers on street prohibited

**11.** No taxi cab or omnibus shall ply for passengers on any road within any area so specified in a notice to be published in the *Gazette* by the Chairman of the Kuala Belait and Seria Municipal Board.

## Penalty

**12.** Any person who contravenes any of the provisions of these Rules is guilty of an offence and liable on conviction to a fine not exceeding \$200.
