### **Rules made under section 203**

### **RELIGIOUS COUNCIL AND KADIS COURTS (CONVERTS) RULES**

Commencement: 1st March 1957

### Citation

**1.** These Rules may be cited as the Religious Council and Kadis Courts (Converts) Rules.

### Form to be completed by prospective converts to Muslim Religion

**2.** Every person wishing to become a convert to the Muslim religion shall submit a written statement, in duplicate, through the Kadis of the district in which he resides, in the form in the Schedule and shall sign such statement in the presence of a witness.

### Kadis to report conversions to Secretary to Majlis

**3.** After a Kadi has converted any person to the Islamic Religion he shall forward to the Secretary to the Majlis report of such conversion together with a copy of the written statement referred to in rule 2.

### Secretary to Majlis to issue certificate of conversion on report

4. The Majlis shall issue to every person on registration of his conversion to the Islamic Religion a certificate in Form B in the Schedule that he has been registered as a convert to that Religion.


