

THE CENSUS ENACTMENT (*Cap. 78*)

The Census Rules, 1971

In exercise of the powers conferred upon him by section 6 of the Census Enactment (*Cap. 78* of the Revised Edition of the Laws of Brunei 1951) the Sultan in Council hereby makes the following Rules :—

Citation and date of commencement

1. These Rules may be cited as the Census Rules, 1971, and are made for the purpose of taking census of the population of the State of Brunei between the First day of January, 1971 and the Thirtieth day of June, 1972 and shall be deemed to have come into force on the 1st of January, 1971.

Census Officers to obtain particulars for census

2. Census Officers shall obtain information concerning the particulars set out in Appendix I hereto in accordance with provisions of the Enactment and any Rules made thereunder.

Information concerning particulars.

3. The information concerning the particulars set out in Appendix I shall be obtained on the appropriate forms substantially set out in Appendix II.

APPENDIX I

Matters in respect of which particulars are required.

1. Name, sex, marital status, date of birth or age.
2. Country of birth, citizenship, residential status and date of arrival.
3. Race, religion, education and literacy.
4. Occupation, profession or trade, employment.
5. Relationship to head of household.
6. Housing conditions, non-agricultural activities by household and agricultural holding.
