

**THE NATIONAL REGISTRATION
ENACTMENT, 1964**

**THE NATIONAL REGISTRATION
(AMENDMENT) REGULATIONS, 1974**

In exercise of the powers conferred upon him by Section 6 of the National Registration Enactment, 1964, the Sultan in Council hereby makes the following Regulations:—

1. These Regulations may be cited as the National Registration (Amendment) Regulations, 1974 and shall be read as one with the National Registration Regulations, 1964 hereinafter referred to as the Principal Regulations. **Citation.**

2. (1) Regulations 5(2) (a) of the Principal Regulations is hereby amended by deleting the words “Blue” and substituting the word “Yellow”. **Amendment of Regulation 5.**

(2) Regulation 5(2) (b) of the Principal Regulations is hereby amended by deleting the words “Red” and substituting the words “Purple”.

3. The First Schedule of the Principal Regulations is hereby revoked and the following new First Schedule substituted in its place, that is to say:— **Amendment of First Schedule.**

FIRST SCHEDULE

(Regulation 5(2))

FORM OF IDENTITY CARD

DESCRIPTION

1. The border on the front of the identity card will bear a security design, the number of the card and the words “KAD PENGENALAN” and “BRUNEI”.

2. The underprint on the front of the identity card will be lithographed with a repetition of the Brunei Government

Crest with spaces for the photograph in the centre and for two thumbprints one on each side of the photograph.

3. The back of the identity card will contain the following particulars:—

(a) Subject of His Highness the Sultan and Yang Di-Pertuan:—

4. The identity card will be 4" x 2½ in size.

5. The identity card will be laminated by a process of placing it between two sheets of transparent plastic material and of using a combination of heat and pressure to join the pieces firmly together."
