

ROAD TRAFFIC ENACTMENT, 1954
Road Traffic (Bandar Seri Begawan
Municipal Board) (Parking Places)
(Amendment) Rules, 1979.

In exercise of the powers conferred by section 87 of the Road Traffic Enactment, 1954, the Bandar Seri Begawan Municipal Board, with the approval of the Licensing Authority, hereby make the following rules —

1. These rules may be cited as the Road Traffic (Bandar Seri Begawan Municipal Board) (Parking Places) (Amendment) Rules, 1979 and shall come into force on the 1st day of August, 1979. Citation.

2. The Road Traffic (Bandar Seri Begawan Municipal Board) (Parking Places) Rules, 1972 (hereinafter referred to as the Principal Rules) are amended in paragraph 2(1) — Amendment of paragraph 2.
 - (a) By deleting the definition of “Hour” and substituting therefor the following definition :
“ “Half an hour” includes part of half an hour”
 - (b) By deleting the words “Hourly Parking” and substituting therefor the words “Half-Hourly Parking”.

3. Paragraph 9(2) of the Principal Rules is amended : Amendment of paragraph 9.
 - (a) By deleting the words “an hour” and substituting therefor the words “half an hour”; and
 - (b) By deleting the words “every hour” and substituting therefor the words “every half an hour”.

4. The Principal Rules are amended — Amendment of paragraph 10.
- (a) In paragraph 10(1) and (2) by deleting the words “hour” wherever it occurs and substituting therefor the words “half an hour”; and
 - (b) In the proviso to paragraph 10 by deleting the figure “\$5.00” and substituting therefor the figure “\$10.00”.
5. Paragraph 11 of the Principal Rules is amended by deleting the word “ten” and substituting therefor the word “twenty”. Amendment of paragraph 11.
6. The Principal Rules are amended in paragraph 16 — Amendment of paragraph 16.
- (a) By deleting the word “and” at the end of paragraph 16(b);
 - (b) By deleting the full-stop at the end of paragraph 16(c) and substituting therefor a semi-colon and adding immediately thereafter the word “and”; and
 - (c) By inserting after paragraph 16(c) the following provision :
 - “(d) A vehicle used by a public servant in respect of which the Board has issued an exemption pass authorising the said vehicle to be parked free of charge in a parking place subject to such conditions as may be specified therein.”
7. Paragraph 25 of the Principal Rules is amended by deleting the word “hourly” and substituting therefor the word “half-hourly”. Amendment paragraph 25.
8. The Schedule to the Principal Rules is repealed and the following Schedule is substituted therefor : Amendment of Schedule.
