## Application of Bandar Seri Begawan Municipal Boards By-Laws to Tutong Municipal Board

In exercise of the powers conferred by section 5 of the Municipal Boards Enactment, the Municipal Board, Tutong, at its meeting on the 21st. day of February, 1980 resolved, which resolution has been confirmed by the Mentri Besar, to apply

to the whole area subject to its control with effect from the 1st. day of March, 1981, the following By-laws passed by the Municipal Board, Bandar Seri Begawan, namely:-

- 1. The Regulation and Control of Buildings and Buildings Operation.
- 2. The Laying-out and Maintenance of Reserved Lands For Recreation and Other Purposes.
- 3. The Planting and Preservation of Trees and Shrubs.
- 4. The Cleaning, Watering, Lighting and Control of Streets.
- 5. Naming Streets and Numbering Houses.
- 6. The Control and Supervision of Drains.
- 7. The Control and Supervision of Latrines, Cesspools, Wells and Water Tanks.
- The Control and Supervision of Stables and Cattle Sheds and Places for Keeping Sheep, Goats, Swine and Poultry.
- 9. The Control and Supervision of Sale of Fresh Provisions and the Licensing of Persons to Hawk Foodstuffs.
- 10. The Establishment and Regulation of Markets.
- 11. The Establishment and Regulation of Slaughter-houses.
- 12. The Regulation of Bakeries.
- 13. The Regulation of Dairies.
- 14. The Regulation of Laundries.
- 15. The Regulation of Street-stalls.
- 16. Seizure and Disposal of Unwholesome Fish, Flesh and other Provisions.
- 17. The Regulation, Inspection and Licensing of Common Lodging Houses, Eating Houses, Jinrikisha Stables, Theatres, Native Inns and other Places of Public Resort.
- 18. The Removal and Disposal of Refuse and Night Soil.
- 19. Regulation of Dangerous, Unhealthy or Offensive Trades or Occupations.

- 20. The Prevention and Removal of Obstructions in the Streets and Verandahs or Footways.
- 21. The Repair or Removal of Ruinous or Dangerous Houses, Mats or Out-buildings, and the Removal of Occupants therefrom.
- 22. Licences and Sign-boards.
- 23. The Conduct of the Business of Sanitary Board.
