• ROAD TRAFFIC (BANDAR SERI BEGAWAN MUNICIPAL BOARD) (PARKING PLACES) (AMENDMENT) RULES, 1983

In exercise of the powers conferred by Section 87 of the Road Traffic Enactment, 1954, the Bandar Seri Begawan Municipal Board, with the approval of the Licensing Authority, hereby makes the following rules:—

1. These rules may be cited as the Road Traffic (Bandar Seri

Begawan Municipal Board) (Parking Places) (Amendment) Rules,

1983 and shall come into force on the 1st. day of December, 1983.

2. The Road Traffic (Bandar Seri Begawan Municipal Board) (Parking Places) Rules, 1972 (hereinafter referred to as "the Principal Rules") is amended by revoking Rule 9 and substituting therefor the

following —

- "9. (1) Where a motor vehicle is parked in contravention of sub-paragraph (1) or (2) of paragraph 8 in relation to the prescribed parking charge
 - (a) in respect of the period during which the motor vehicle has been parked in a parking place without payment of the prescribed charge; or

commencement.

(b) in respect of any period beyond the period stated in the official receipt issued by the parking attendant;

it shall be the duty of the parking attendant to issue an advice note to be affixed to the windscreen or any other conspicuous part of the motor vehicle requesting the owner of the vehicle to pay the appropriate parking charge before the expiration of 7 days from the date of the advice note failing which a surcharge will be imposed.

- (2) An advice note under sub-paragraph (1) shall include the following particulars
 - (a) the registration number of the vehicle;
 - (b) the date of issue of the advice note;
 - (c) the time of issue;
 - (d) the charge payable;
 - (e) the parking space number and the locality in which it is situated.
- (3) If the motor vehicle for which an advice note has been issued remains parked after the expiry of half an hour from the time of the issue of the previous advice note the parking attendant shall issue another advice note and shall continue to do so at the end of every half an hour thereafter, for so long as such motor vehicle remain parked in that parking space."
- Amendment of Rule 10 of the Principal Rules is revoked and the following substituted therefor
 - "10. (1) Any person who fails to pay in accordance with the advice note under sub-paragraph 9(1) the prescribed parking charge due by 4 p.m. on the seventh day from the date of such advice note shall before the expiration of 14 days from the date of such advice note pay to the Board the prescribed parking charge and a surcharge of five dollars for every half hour or part thereof—
 - (a) during which the motor vehicle has been parked in a parking place without payment of the prescribed charge; or
 - (b) during which the motor vehicle has remained parked in the parking place after the expiry of the authorised parking period.

- (2) The surcharge payable under sub-paragraph (1) shall not exceed \$50 on any one occassion."
- 4. Rule 11 of the Principal Rules is revoked and the following substituted therefor Amendment of Rule 11.
- "Offence. 11. Any person who fails to pay the prescribed parking charge and surcharge under paragraph 10 shall be guilty of an offence."
