# THE CONSTITUTION (TRANSFER OF FUNCTIONS AND CONSEQUENTIAL PROVISIONS) ORDER, 1985

In exercise of the powers conferred by paragraph 1 of the Second Schedule to the Emergency (Constitution of Brunei Darussalam) (Amendment) Order, 1983, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order:—

1. This Order may be cited as the Constitution (Transfer of Functions and Consequential Provisions) Order, 1985 and shall be deemed to have into force on 1st January, 1986.

Citation and commencement.

2. In this Order -

First column

Interpretation.

- "functions" includes any powers, duties, privileges or benefits conferred or imposed by any written law on any person or authority;
- "Minister" in Part A of the Schedule means the Minister of Communications and in Part B means the Minister of Finance.
- 3. The functions confered or imposed on the person or authority specified in the first column of the Schedule by the provisions of law specified opposite thereto in the second column of that Schedule are hereby transfered to the person or authority specified opposite thereto in the third column of that Schedule.
