**ROAD TRAFFIC ACT**  
(Chapter 68)

**Road Traffic**  
(Kuala Belait and Seria Municipal Board)  
(Parking Places) (Amendment) Rules, 1992

In exercise of the powers conferred by section 92 of the Road Traffic Act (Chapter 68), the Kuala Belait and Seria Municipal Board, with the approval of the Licensing Authority, hereby makes the following rules :

1. These rules may be cited as the Road Traffic (Kuala Belait and Seria Municipal Board) (Parking Places) (Amendment) Rules, 1992 shall come into force on the 1st day of January, 1993. Citation and commencement.

2. The Road Traffic (Kuala Belait and Seria Municipal Board) (Parking Places) Rules 1979, is amended by revoking paragraph 15 and substituting therefore the following :- Amendment of Paragraph 15.

Suspension of use of parking places, spaces.

"15 (1) The Board may suspend the use of a parking place or space :-

- (a) for the purpose of facilitating the movement of traffic or of promoting its safety ; or
- (b) for the purpose of any building operation demolition or excavation adjacent to the parking space or the maintenance improvement or reconstruction of the parking space or the laying erection alteration or repair to in or adjacent to the parking space of any sewer or of any cable pipe, main or apparatus for the supply of water or electricity or of any telegraphic line ; or
- (c) for the convenience of occupiers of premises adjacent to the parking space on any occasion for the removal or delivery of furniture from or to any such premises ; or
- (d) on any occasion on which it is likely by reason of some special attraction that any road will be thronged or obstructed ; or

- (e) for the convenience of the occupiers of premises adjacent to the parking space at the time of weddings or funerals or other special occasions ; or
- (f) for such other reasons as the Board may think fit.

(2) On any suspension as aforesaid, a duly authorised representative of the Board shall affix an appropriate notice at or near the parking space in question ; and it shall be unlawful for any person to park any motor vehicle in such parking place of space except in relation to the purpose for which the suspension was made.

(3) For the various purposes described in sub-paragraph (1) and upon any such suspension, the Board may require payment from the person whose action was responsible for the suspension, of the charges specified hereunder :

Not exceeding 15 days	\$6.00 per day
Not exceeding 30 days	\$5.00 per day
Not exceeding 180 days	\$4.00 per day
Not exceeding 365 days	\$3.00 per day
More than 365 days	\$2.00 per day
