THE ROYAL BRUNEI POLICE FORCE ACT
(CHAPTER 50)

THE POLICE (AMENDMENT) REGULATIONS, 2000

In exercise of the power conferred by section 64 of the Royal Brunei Police Force Act, His Majesty the Sultan and Yang Di-Pertuan in Council hereby makes the following Regulations —

Citation. 1. These Regulations may be cited as the Police (Amendment) Regulations, 2000.

Insertion of new regulation 66A. 2. The Police Regulations, 1958, in these Regulations referred to as the principal Regulations, are amended by inserting the following new regulation 66A immediately after regulation 66 —

"Fees for copies of documents. 66A. Fees for copies of public documents in the custody of a police officer which any person has, subject to consent being obtained, a right to inspect shall be at the rates set out in Schedule 'G'."

Amendment of regulation 68. 3. Regulation 68 of the principal Regulations is amended by deleting paragraph (1) and substituting the following new paragraph therefor —

"Fees for private purposes including bullion escort services. (1) Fees for the employment of members of the Force for private purposes including bullion escort services shall be at the rates set out in Schedule 'H'."

Addition of new Schedules 'G' and 'H'. 4. The principal Regulations are amended by adding the following two new Schedules 'G' and 'H' —
