UNIVERSITI BRUNEI DARUSSALAM ACT (CHAPTER 157)

UNIVERSITI BRUNEI DARUSSALAM (AMENDMENT OF SCHEDULE) ORDER, 2000

In exercise of the power conferred by section 13 of the Universiti Brunei Darussalam Act, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement.

1. This Order may be cited as the Universiti Brunei Darussalam (Amendment of Schedule) Order, 2000 and shall commence on the date of its publication in the Gazette.

Amendment of section 2 of Schedule to Chapter 157.

2. Subsection (1) of section 2 of the Schedule to the Universiti Brunei Darussalam Act, in this Order referred to as the Act, is amended, in the definition of "principal officer", by inserting "an Assistant Vice-Chancellor," immediately after "Deputy Vice-Chancellor," in the second line.

Substitution of section 12 of Schedule.

- 3. Section 12 of the Schedule to the Act is repealed and the following new section substituted therefor $\,-\,$
- "Assistant Vice-Chancellor."

 12. The Council may appoint one or more Assistant Vice-Chancellors on such terms and conditions of service as the Council may determine."

Amendment of section 17 of Schedule.

- 4. Section 17 of the Schedule to the Act is amended by repealing subsections (1) and (2) and substituting the following new subsections therefor
 - "(1) The Senate shall consist of
 - (a) the Vice-Chancellor, who shall be Chairman;
 - (b) the Deputy Vice-Chancellors, if appointed;
 - (c) the Assistant Vice-Chancellors;
 - (d) the heads of institutions:
 - (e) the Dean of Students;

- (f) the Chief Librarian;
- (g) the Deputy Deans or deputy heads of institutions;
- (h) one representative of the full-time professors of each institution, not including visiting professors, elected by the professors of the institution concerned, who shall hold office for two years if qualified but who shall be eligible for reappointment:

Provided that if a professor is already a member of the Senate ex-officio, that professor shall not be eligible to take part in the election of such representative; and

- (i) such other persons by name or by office as may be prescribed by statute or appointed by the Senate, after consultation with the Vice-Chancellor, to hold office for such period as the Senate may determine.
- (2) The Vice-Chancellor may appoint a Deputy Vice-Chancellor or an Assistant Vice-Chancellor to deputise for him as Chairman at any meeting of the Senate if the Vice-Chancellor is unable to attend the meeting:

Provided that if no Deputy Vice-Chancellor or Assistant Vice-Chancellor is able to attend the meeting, then the Vice-Chancellor may appoint any member of the Senate to deputise for him as Chairman.".

Substitution of section 32 of Schedule.

- 5. Section 32 of the Schedule to the Act is repealed and the following new section substituted therefor —
- "Publication of statutes and regulations.
- 32. (1) When any statute or regulation is made, amended or revoked, every such statute or regulation, amendment or revocation shall be published in the University Bulletin and in such form or in any publication of the University as may be determined by the Vice-Chancellor.
 - (2) Nothing in this section shall apply to
 - (a) any regulation containing only instructions to examiners or invigilators or details concerning courses of study or syllabi or examinations;
 - (b) any statute or regulation which the Council resolves not to publish.".
