**CONSTITUTION OF BRUNEI DARUSSALAM**  
**(Order under section 83(3))**

**EMERGENCY (BRUNEI NATIONALITY ACT) (AMENDMENT) ORDER, 2000**

In exercise of the power conferred by subsection (3) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

**Citation.**

1. This Order may be cited as the Emergency (Brunei Nationality Act) (Amendment) Order, 2000.

**Amendment of section 4 of Chapter 15.**

2. Section 4 of the Brunei Nationality Act is amended, in subsection (1) —

- (a)* by adding the following immediately after "Tutong;" at the end of paragraph *(a)* —

"and any person born outside Brunei before, on or after the appointed day, whose father was, at the time of birth of such person, a subject of His Majesty by operation of law under this paragraph or paragraph *(c)*/*(i)* and was employed outside Brunei in the service of the Government, by any company registered in Brunei or in such special circumstances as His Majesty thinks fit, if the birth of such person was registered at a Brunei Consulate or in Brunei within 6 months of its occurrence, or such longer period as His Majesty may in any particular case allow;"

- (b)* by adding the following immediately after "Act;" at the end of paragraph *(b)* —

"and any person born outside Brunei before, on or after the appointed day, whose father was, at the time of birth of such person, a subject of His Majesty by operation of law under this paragraph or paragraph *(c)*/*(ii)* and was employed outside Brunei in the service of the Government, by any company registered in Brunei or in such special circumstances as His Majesty thinks fit, if the birth of such person was registered at a Brunei Consulate or in Brunei within 6 months of its occurrence, or such longer period as His Majesty may in any particular case allow;"

- (c)* by adding the following immediately after "His Majesty" in the last line of paragraph *(d)* —

"and any person born outside Brunei before, on or after the appointed day, whose father was, at the time of birth of such person, a subject of His Majesty and was employed outside Brunei in the service of the Government, by any company registered in Brunei or in such special circumstances as His Majesty thinks fit, if the birth of such person was registered at a Brunei Consulate or in Brunei within 6 months of its occurrence, or such longer period as His Majesty may in any particular case allow;"; and

(d) by inserting "or 6 or by naturalisation under section 8" immediately after "section 5" in the fourth line of paragraph (e).
