**YAYASAN SULTAN HAJI HASSANAL BOLKIAH ACT**  
**(AMENDMENT OF SCHEDULE) ORDER, 2003**

In exercise of the power conferred by section 5 of the Yayasan Sultan Haji Hassanal Bolkiah Act, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

**Citation and commencement.**

1. This Order may be cited as the Yayasan Sultan Haji Hassanal Bolkiah Act (Amendment of Schedule) Order, 2003 and shall be deemed to have commenced on the 5th. October, 1992.

**Amendment of section 4 of Schedule to Chapter 166.**

2. Section 4 of the Schedule to the Yayasan Sultan Haji Hassanal Bolkiah Act, in this Order referred to as the Act, is amended —

(a) in subsection (2), by deleting "Deputy Chairman" from the first line and by substituting "first Deputy Chairman, second Deputy Chairman" therefor;

(b) in subsection (6), by deleting "Deputy Chairman" from the last two lines and by substituting "first Deputy Chairman, and in case he is, at that time, unable to exercise those functions owing to any such causes, by the second Deputy Chairman until such time when either the Chairman or the first Deputy Chairman is able to exercise those functions, whichever is earlier" therefor;

(c) in subsection (7), by deleting "the Deputy Chairman" from the last line and by substituting "either of the Deputy Chairmen" therefor.

**Amendment of section 6 of Schedule.**

3. Section 6 of the Schedule to the Act is amended, in subsection (6) —

(a) by deleting the fullstop and by substituting a colon therefor;

(b) by adding the following proviso —

"Provided that, if such absence or inability is for a period of less than 6 continuous calendar months, the power to make any such appointment shall be vested in the Chairman who shall notify His

Majesty the Sultan and Yang Di-Pertuan of the appointment from time to time."

**Amendment of section 7 of Schedule.**

**4. Section 7 of the Schedule to the Act is amended —**

(a) in subsection (2), by deleting "Deputy Chairman" from the second line and by substituting "first Deputy Chairman, second Deputy Chairman" therefor;

(b) in subsection (4), by deleting "and the Deputy Chairman" from the last line and by substituting ", the first Deputy Chairman and the second Deputy Chairman," therefor;

(c) by adding the following 5 new subsections —

"(6) The members of the Committee of Governors shall be appointed from among subjects of His Majesty the Sultan and Yang Di-Pertuan who are Muslims according to Ahli Sunnah Wal-Jamaah.

(7) If the Chairman is unable to exercise his functions under this Constitution owing to illness, absence from Brunei Darussalam or for any other cause whatsoever, his functions shall be exercised by the first Deputy Chairman, and in case he is, at that time, unable to exercise those functions owing to any such causes, by the second Deputy Chairman until such time when either the Chairman or the first Deputy Chairman is able to exercise those functions, whichever is earlier.

(8) The Chairman shall summon meetings as often as may be required and at every meeting of the Committee of Governors, a quorum shall consist of 3 members, including the Chairman or either of the Deputy Chairmen.

(9) The Chairman shall have a casting vote in the event of an equality of votes.

(10) The Committee of Governors may invite any person as it thinks fit to attend a meeting of the Committee of Governors for the purpose of giving advice to the Committee of Governors on any matter."
