(CHAPTER 1)**

LAW REVISION ORDER NO. 3 OF 2008

In exercise of the powers conferred by sections 5(1) and (2) of the Law Revision Act, the Attorney General hereby makes the following Order —

Citation and commencement.

1. This Order may be cited as Law Revision Order No. 3 of 2008 and shall commence on the day it is made.

Removal and substitution of pages.

2. (1) The removal from the Laws is hereby directed of the pages specified in the third column of Part A of the First Schedule hereto with reference to the repealed written laws specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.

(2) The inclusion in the Laws is hereby authorised, in respective substitution of the pages directed to be removed under sub-paragraph (1), of the pages specified in the second column of Part B of the First Schedule with reference to those repealed written laws and bearing on the face or overleaf the legend specified in the third column thereof.

Removal of pages.

3. The removal from the Laws is hereby authorised of the pages specified in the third column of the Second Schedule hereto with reference to the repealed written law specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.
