**CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Article 83(3))**

HALAL CERTIFICATE AND HALAL LABEL (AMENDMENT) ORDER, 2012

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order –

Citation.

1. This Order may be cited as the Halal Certificate and Halal Label (Amendment) Order, 2012.

Amendment of section 2 of S 39/05.

2. Section 2 of the Halal Certificate and Halal Label Order, 2005, in this Order referred to as the principal Order, is amended by inserting the following new definition immediately before the definition of “certificate” –

““applicant” means a person who makes an application under section 4(1) or 10(1);”.

Amendment of section 6.

3. Section 6 of the principal Order is amended, in subsection (2), by deleting “one year” and by substituting “3 years” therefor.

Amendment of section 7.

4. Section 7 of the principal Order is amended, in subsection (2), by deleting “one year” and by substituting “3 years” therefor.

Insertion of new section 42B.

5. The principal Order is amended by inserting the following new section immediately after section 42A –

“Display of notices.

42B. An applicant shall, if so directed by the Majlis, display such notices in such places, phrase them in such manner or cause them to be of such size, as the Majlis may consider fit.”.

Amendment of section 46.

6. Section 46 of the principal Order is amended —

(a) in the section heading, by inserting “or a permit” immediately after “certificate”;

(b) in subsection (1) —

(i) by inserting “or permit” immediately after “certificate” in the first line;

(ii) by inserting “or a replacement permit” immediately after “certificate” in the first time it appears in the second last line;

(iii) by inserting “or replacement permit” immediately after “certificate” in the second time it appears in the second last line;

(c) in subsection (2) —

(i) by inserting “or a replacement permit” immediately after “certificate” in the first line;

(ii) by inserting “or permit” immediately after “certificate” wherever it appears in the last two lines.

Substitution of Fourth Schedule.

7. The principal Order is amended by repealing the Fourth Schedule and by substituting the following new Fourth Schedule therefor —

“FOURTH SCHEDULE	(sections 6(1), 12(1), 43(5), 45 and 46(1))
FEES	
Issue or renewal of Halal Certificate	\$90
Issue or replacement of Halal Certificate or permit	\$10
Issue of permit	\$50.”
