AIRPORT FEES AND CHARGES (AMENDMENT) REGULATIONS, 2013

In exercise of the power conferred by section 55(3) of the Civil Aviation Order, 2006, the Minister of Communications, with the approval of His Majesty the Sultan and Yang Di-Pertuan, hereby makes the following Regulations —

**Citation.**

1. These Regulations may be cited as the Airport Fees and Charges (Amendment) Regulations, 2013.

**Amendment of regulation 8 of Airport Fees and Charges Regulations in Chapter 113.**

2. Regulation 8 of the Airport Fees and Charges Regulations, in these Regulations referred to as the principal Regulations, is amended by —

(a) inserting “(1)” immediately before “The” in the first line;

(b) by adding the following new sub-regulation —

“(2) the Director may, with the approval of the Minister, grant exemption wholly or in part, from landing charges and for such period as he may determine, in respect of the following —

(a) a Flying Club approved by him under regulation 8(1)(e);

(b) in respect of private aircraft for which he has issued a special landing permit under regulation 7;

(c) such aircraft or class of aircraft as he may consider desirable.”.

**Substitution of regulation 10.**

3. Regulation 10 of the principal Regulations is repealed and the following new regulation substituted therefor —

**“Exemptions from parking charges.**

10. (1) The following classes of aircraft shall be exempt from payment of parking charges —

(a) The classes of aircraft listed in regulation 8(1)(a), (b) and (c).

(b) Such other aircraft or classes of aircraft as the Minister may approve.

(2) The class of aircraft mentioned in regulation 8(1)(c) shall be exempt from parking charges from the first 48 hours of parking.

(3) The Director may, with the approval of the Minister, grant exemption wholly or in part from parking charges, and for such period as he may determine, in respect of the following —

(a) a Flying Club approved by him under regulation 8(1)(e);

(b) in respect of private aircraft for which he has issued a special landing permit under regulation 7;

(c) such aircraft or class of aircraft as he may consider desirable.”.
