FREE TRADE ZONES (DECLARED AREAS) NOTIFICATION

In exercise of the power conferred by section 4 of the Free Trade Zones Order, 2014, the Minister of Finance may, with the approval of His Majesty the Sultan and Yang Di-Pertuan, hereby makes the following Notification —

1. This Notification may be cited as the Free Trade Zones (Declared Areas) Notification.

**Free trade zone**

2. The area set out in Schedule 1 is hereby declared to be a free trade zone which boundary is delineated in the plan set out in Schedule 2.

SCHEDULE 1

TERUNJING INDUSTRIAL SITE

All that area occupied by 'TERUNJING INDUSTRIAL SITE FREE TRADE ZONE' containing an area of 95 hectares and bounded by Rimba Highway Road, Jalan Utama Terunjing Road, Muara-Tutung Highway Road and Kampung Lambak.

The boundary commences at the north-most corner of the aforesaid 'TERUNJING SITE FREE TRADE ZONE' which point's co-ordinates are North 551744.0000 metres and East 584253.0000 metres of Kampung Lambak A and runs approximately as follows:

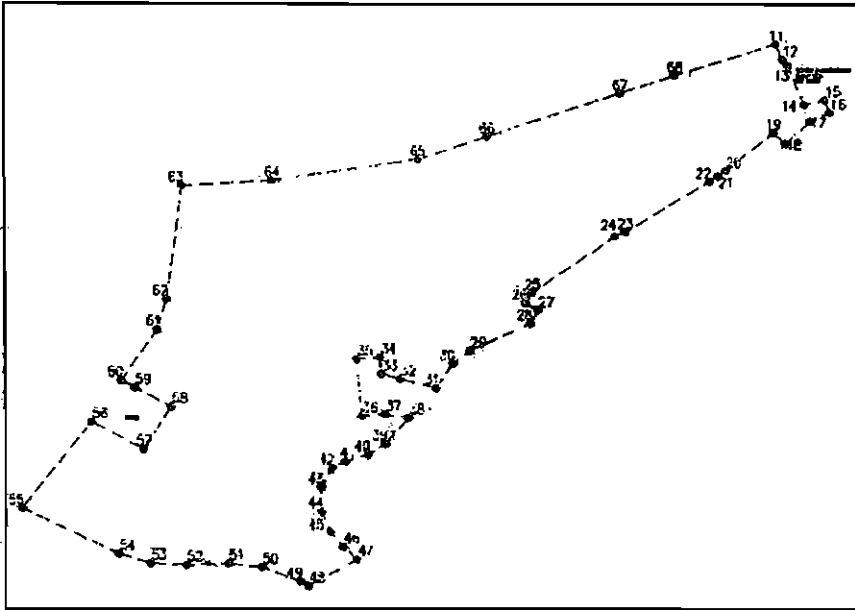
