#### LAW REVISION ORDER NO. 6 OF 2021

In exercise of the powers conferred by section 5(1) and (2) of the Law Revision Act, the Attorney General hereby makes the following Order —

#### Citation and commencement

1. This Order may be cited as the Law Revision Order No. 6 of 2021 and shall commence on the day it is made.

#### Inclusion of pages

2. The inclusion in the Laws of Brunei of the pages specified in the third column of Schedule 1 hereto with reference to the written law specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.

#### Removal and substitution of pages

- 3. (1) The removal from the Laws is hereby directed of the pages specified in the third column of Part A of the Schedule 2 hereto with reference to the written laws specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.
