LAW REVISION ORDER NO. 6 OF 2021

In exercise of the powers conferred by section 5(1) and (2) of the Law Revision Act, the Attorney General hereby makes the following Order —

Citation and commencement

1. This Order may be cited as the Law Revision Order No. 6 of 2021 and shall commence on the day it is made.

Inclusion of pages

2. The inclusion in the Laws of Brunei of the pages specified in the third column of Schedule 1 hereto with reference to the written law specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.

Removal and substitution of pages

3. (1) The removal from the Laws is hereby directed of the pages specified in the third column of Part A of the Schedule 2 hereto with reference to the written laws specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.

(2) The inclusion in the Laws is hereby authorised, in substitution of the pages directed to be removed under sub-paragraph (1), of the pages specified in the third column of Part B of the Schedule 2 and bearing on the face or overleaf the legend specified in the fourth column thereof, with reference to the written laws referred to in the first and second columns thereof.
