ROYAL BRUNEI POLICE FORCE ACT (AMENDMENT) ORDER, 2021

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation

1. This Order may be cited as the Royal Brunei Police Act (Amendment) Order, 2021.

Amendment of section 8 of Chapter 50

2. Section 8 of the Royal Brunei Police Force Act, in this Order referred to as the Act, is amended by deleting "Subject to sections 43 and 44 a" and by substituting "A" therefor.

Amendment of section 9

3. Section 9 of the Act is amended, in subsection (1), by deleting "Subject to sections 43 and 44 an" and by substituting "An" therefor.

Amendment of section 30

4. Section 30 of the Act is amended —

(a) by deleting "or dismissed from the Force" from the fourth and fifth lines and by substituting ", dismissed from the Force or both" therefor;

(b) by inserting "be reduced in rank or dismissed from the Force" immediately after "or" in the fifth last line.

Substitution of section 43

5. Section 43 of the Act is repealed and the following new section is substituted therefor —

"Recommendation of Commission

43. (1) In the exercise of the powers conferred upon him by sections 8, 9(1) and 30, His Majesty the Sultan and Yang Di-Pertuan may consult the Commission.

(2) His Majesty the Sultan and Yang Di-Pertuan is not bound to act in accordance with the recommendation of the Commission."

Amendment of section 44

6. Section 44 of the Act is amended, in paragraph *(b)*, by deleting "sections 8(1), 9(1) or 30 and may further provide that any such person shall be free from the restriction imposed by section 43" from the last three lines and by substituting "section 8, 9(1) or 30" therefor.
