CONSTITUTION OF BRUNEI DARUSSALAM (Order made under Article 83(3) and (5))

### SUPPLEMENTARY SUPPLY (2024/2025) (NO. 2) ORDER, 2025

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 44/2024) dated the 20th day of June 2024 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam.

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest.

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service.

AND WHEREAS it is provided by section 10(3) of the Constitution (Financial Procedure) Order that His Majesty the Sultan and Yang Di-Pertuan may, if he is satisfied that there has risen an urgent and unforeseen need for expenditure for which no other provision exists and for which funds cannot be provided under section 13(4) of the Constitution (Financial Procedure) Order, make advances from the Contingencies fund to meet that need.

AND WHEREAS the sum of five billion and one hundred and ninety million dollars (\$5,190,000,000.00) has been provided by the Supply (2024/2025) Act, 2024 (Act 1 of 2024).

AND WHEREAS the sum of two hundred and fifty-nine million, one hundred and forty-one thousand and three hundred and sixty-one dollars (\$259,141,361.00) has been provided by the Supplementary Supply (2024/2025) (No. 1) Order, 2025.

AND WHEREAS it is now requisite to make a further provision of thirty-nine million, five hundred and fifty-eight thousand and eighty-three dollars (\$39,558,083.00).

NOW, THEREFORE, in exercise of the powers conferred by Article 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order –

## Citation

1. This Order may be cited as the Supplementary Supply (2024/2025) (No. 2) Order, 2025.

# Further expenditure for the year 2024/2025, appropriation and replacement of sum advanced from Contingencies Fund

2. (1) The issue of a sum not exceeding thirty-nine million, five hundred and fifty-eight thousand and eighty-three dollars (\$39,558,083.00) out of the Consolidated Fund for expenditure on the services specified in the second column of the Schedule for the year 2024/2025, not provided or not fully provided for by the Supply (2024/2025) Act, 2024 (Act 1 of 2024) and the Supplementary Supply (2024/2025) (No. 1) Order, 2025, is hereby authorised.

(2) For the purposes of subsection (1), the sum specified in the third column of the Schedule is appropriated to the head of expenditure specified in the first column thereof.

(3) The replacement of such sum with the sum specified in the fourth column of the Schedule, being the sum advanced from the Contingencies Fund, is hereby authorised.
