
Core Responsibilities

• To prepare the updated revised texts of all types of Laws of Brunei Darussalam, including the Constitution of Brunei Darussalam through the law revision process.

HOW DO WE CHOOSE WHAT LAWS TO BE REVISED?

- Laws are chosen based on section 7(a) and section 7(b) -
- Section 7(a) "a new revised edition of any written law already included in the Laws which has been amended during the year ending on the preceding 31st December;"
- Section 7(b) "any written law enacted or made during the year ending on the preceding 31st December, other than a written law the sole effect of which was to amend any other written law;"

"executive director" means a director who is concurrently an executive officer and "non-executive director" shall be construed accordingly;



> (c)) any company converted into a private company pursuant to section 30,¶

being a company which has not ceased to be a private company under section 30:¶

"prospectus" means any prospectus, notice, circular, advertisement or other invitation, offering to the public for subscription or purchase of any shares or debentures of a company;¶

"public agency" includes -

(a)) the Government, including any ministry, department or agency:

(b)) any board, commission, committee or similar body, whether corporate or unincorporated, established by or under any written law for a public functions;¶

(c)) any other board, commission, committee or similar body appointed by the Government or by statutory body, for a public purpose;¶

"Registrar" means the Registrar of Companies appointed under section 288, and includes any Deputy Registrar or Assistant Registrar;

"resident in Brunei Darussalam" has the same meaning as in section 2 of the Income Tax Act (Chapter 35);



Exit and Entry Charges CAP. 232 5

EXIT AND ENTRY CHARGES ACT¶

An Act to make provision for the imposition of charges on persons intending to leave or enter, or leaving and entering Brunei Darussalam, by land and for matters connected therewith or incidental thereto.

> Commencement: 1st August 2020 [S 33/2020]

PART 1¶

PRELIMINARY

Citation ¶

1.) This Act may be cited as the Exit and Entry Charges Act. ¶

Non-derogation¶

2.) The provisions of this Act are in addition to and not in derogation of any other written law in relation to the imposition of charges upon leaving Brunei Darussalam.

Application of Act¶

3.) (1) This Act applies within and outside Brunei Darussalam.

2) (2)) This Act does not apply to a person or class of persons specified in Schedule 1.¶

Interpretation¶

"charges" means the exit charges and entry charges payable under section 6(1);¶

"Controller" means the Controller of Customs and Excise appointed under section 3(1) of the Customs Order, 2006 (\$ 39/2006);¶

"driver" means a driver of a vehicle and includes a rider;

POWERS OF ATTORNEY GENERAL IN LAW REVISION ACT (CHAPTER 1)

- Section 15(c) "to alter the order of the provisions in any written law and, in all cases where it is
 necessary to do so, to renumber the provisions of any written law;"
- Section 15(h) "to add a long title, a short title or a citation to any written law which may require it, and, where desirable, to alter the long title, short title or citation of any written law;"
- Section 15(i) "to shorten, simplify, clarify and otherwise alter the phraseology of any written law;"
- Section 15(j) "to correct grammatical and typographical errors, or any clerical or printing errors in any written law, and for the purpose to make verbal additions, omissions or alterations not affecting the meaning of any written law;"

• Section 15(m) "to correct cross-references;"

 Section 15(n) "to make such formal alterations as to names, localities, offices, titles, and otherwise as may be necessary to bring any written law into conformity with the circumstances of Brunei Darussalam;"

 Section 15(p) "to do all things relating to form and method which may be necessary for the perfecting of the Laws;"

However, Attorney General has no power to alter the substance of written law

Need amendment to alter substance of any written law

Chapter 1 - Section 16(1):

No power to make alterations of substance

16 (1) Nothing in this Act shall be construed to confer power on the Attorney General to alter the substance of any written law.

LAW REVISION ACT (Chapter 1)

LAW REVISION ORDER NO. 1 OF 2019

In exercise of the powers conferred by section 5(1) and (2) of the Law Revision Act, the Attorney General hereby makes the following Order —

Citation and commencement

 This Order may be cited as the Law Revision Order No. 1 of 2019 and shall commence on the day it is made.

Removal and substitution of pages

2. (1) The removal from the Laws is hereby directed of the pages specified in the third column of Part A of the Schedule hereto with reference to the written law specified in the first and second columns thereof and bearing on the face or overleaf the legend specified in the fourth column thereof.

(2) The inclusion in the Laws is hereby authorised, in substitution of the pages directed to be removed under sub-paragraph (1), of the pages specified in the third column of Part B of the Schedule and bearing on the face or overlaaf the legend specified in the fourth column thereof, with reference to the written law referred to in the first and second columns thereof.
