VICAR APOSTOLIC OF KUCHING  
(INCORPORATION) ACT

**An Act for the incorporation of the Vicar Apostolic of Kuching and matters incidental thereto** 12 of 1953

*Commencement: 11th August 1973*

1. This Act may be cited as the Vicar Apostolic of Kuching (Incorporation) Act. Short title

2. (1) The lawful holder for the time being of the office of Vicar Apostolic of Kuching is hereby constituted a body corporate under the name of Vicar Apostolic of Kuching, hereinafter called the corporation. Vicar Apostolic of Kuching to be a body corporate

(2) The corporation for the purposes of this Act may sue and be sued in its said name and shall have perpetual succession and a corporate seal.

3. The corporation may acquire, purchase, take, hold and enjoy movable and immovable property of every description and may surrender and yield up, charge, lease, sub-lease, re-assign, transfer or otherwise dispose of, or deal with, any movable or immovable property vested in the corporation upon such terms as to the corporation seems fit. Powers

4. All immovable property situated in Brunei and heretofore conveyed or assigned to or vested in the Catholic Mission, North Borneo, or the Prefect Apostolic of North Borneo, whether with or without the name of the ecclesiastic for the time being holding that office, is hereby vested in the corporation for the respective estates and interests for which the same is held. Vesting of property

5. Any deed, document or other instruments, the operation of which has not lapsed or been discharged prior to the date of commencement of this Act and in which appears the Documents

name of the Catholic Mission, North Borneo, or the Prefect Apostolic of North Borneo shall be read and construed as if there were substituted therefor the corporate name of the Vicar Apostolic of Kuching.

Use of corporate seal

6. All deeds, documents and other instruments requiring the seal of the corporation shall be sealed with the seal of the corporation in the presence of the Vicar Apostolic of Kuching for the time being or his attorney duly authorised by a power of attorney deposited under section 3 of the Powers of Attorney Act, and shall also be signed by the Vicar Apostolic of Kuching for the time being or his attorney so authorised as aforesaid, and such signing shall be sufficient evidence that the said seal was duly and properly affixed and that the same is the lawful seal of the corporation.
