THE RELIGIOUS COUNCIL AND KATHIS COURTS ENACTMENT, 1955

The Religious Council and Kathis Courts

(Wakaf of Mosque Sites), Rules, 1974

In exercise of the powers conferred by Section 202 of the Religious Council and Kathis Courts Enactment, 1955, His Highness the Sultan in Religious Council has made the following rules :

1. These rules may be cited as the Religious Citation. Council and Kathis Courts (Wakaf of Mosque Sites) Rules, 1974, and shall be deemed to have come into force on 1st January, 1974.

2. Any person who intends to dedicate his land Intetion to for the purpose of a mosque site (hereinafter dedicate land. referred to as the person concerned) shall personally inform a Kathi of his intention.

3. The Kathi shall investigate the position and Kathi to investisuitability of the land for such purpose, and shall to Majlis. make a report to the Majlis Ugama Islam (hereinafter referred to as the Majlis).

4. (1) The Majlis shall, after considering the report Declaration by of the Kathi, and having carried out such further the person concerned. investigation as it considers necessary, determine whether or not the land is suitable for such purpose.

(2) If the Majlis considers that the land is suitable, the person concerned shall be required to make declaration in the form in the Schedule.

(3) Where the land is considered to be unsuitable, or for any other reasons it is considered that the intended dedication of the land is undesirable, the Majlis shall notify the person concerned, who may nevertheless, if he so insists, make a declaration in the form in the Schedule.

5. A declaration made under paragraph 4 shall Power of the together with the recommendations, if any, of the Sultan to valide Majlis be submitted to His Highness the Sultan, who may at his discretion sanction and validate the same in writing.

6. The Majlis shall cause to be registered in its Registration name under the Land Code any land which is sub- Land Code. ject of the dedication so sanctioned and validated.
