

**THE ROAD TRAFFIC ENACTMENT, 1954**

**Road Traffic (Compounding of Offences)  
(Amendment) Rules, 1981.**

In exercise of the powers conferred upon Him by section 86A of the Road Traffic Enactment, 1954, the Mentri Besar hereby makes the following Rules:-

1. These Rules may be cited as the Road Traffic (Compounding of Offences) (Amendment) Rules, 1981. Citation

2. Rule 3 of the Road Traffic (Compounding of Offences) Rules, 1967 (hereinafter referred to as the Principal Rules) is revoked and the following rule is substituted — Amendment of  
Rule 3

“3. (1) The offences contained in the First Schedule to these Rules are hereby prescribed as offences which may be compounded by the Commissioner of Police or any Police Officer not below the rank of Assistant Superintendent specially authorised by name in that behalf by the Mentri Besar in accordance with section 86A of the Enactment.

(2) The offence contained in the Second Schedule to these Rules is the offence which may be compounded by the Controller of Land Transport in accordance with section 86A of the Enactment.”

3. Rule 4 of the Principal Rules of revoked and the following rule is substituted —

“4. (1) When an offer of composition of any offence is made and accepted payment shall be made by cash or money order to the police officer authorised to make such offer of composition or to the Controller as the case may be, or to the office or police station specified in the offer of composition.

(2) When payment is made in accordance with paragraph (1) of this Rule, such payment shall be accounted for in the ordinary way and a receipt shall be issued for such payment to the person to whom the offer of composition was made.”

4. (1) The existing SCHEDULE to the Principal Rules is numbered as the “THIRD SCHEDULE” and rule 5 of the Principal Rules is amended by inserting the word “Third” immediately before the word “Schedule”.

(2) Form No. 1 in the Third Schedule (as numbered by these Rules) is amended by deleting the words “section 81(1) (c)” wherever it occurs and substituting the words “section 32A”, and by dele-

ting the words “two hundred dollars” in paragraph 3 and substituting the words “one thousand dollars”.

5. The following “FIRST SCHEDULE” and “SECOND SCHEDULE” are inserted in the appropriate place — Insertion of new Schedules

### FIRST SCHEDULE

- (a) offences under sections 23, 24, 33, 35, 37(1), 70(3) and 78 of the Enactment,
- (b) offences under regulations 14, 19, 20, 23, 24, 27, 29, 30, 31, 32, 33, 33A, 34, 36, 48, 49, 50, 51, 53, 55, 56, 57, 58, 60, 74, 75, 76, 101, 104, 106, 107, 108, 109, 112, 134, 146, 147, 148, 149, 152, and 153 of the Road Traffic Regulations,
- (c) an offence under rule 2 of the Removal of Vehicles Rules, 1968,
- (d) offences under rules 3, 4, 6, 7 and 8 of the Road Traffic (Bandar Seri Begawan Municipal Board) (Bus and Taxi Stands) Rules, 1963, and
- (e) offences under rules 3, 4, 6, 7 and 8 of the Road Traffic (Kuala Belait/Seria Municipal Board) (Bus and Taxi Stands) Rules, 1963.

## SECOND SCHEDULE

- (a) an offence under section 72 of the Enactment.”
