

No. S 29 — ROAD TRAFFIC ENACTMENT, 1954

ROAD TRAFFIC (BANDAR SERI BEGAWAN MUNICIPAL BOARD)
(PARKING PLACES) (AMENDMENT) RULES, 1983

In exercise of powers conferred by section 87 of the Road Traffic Enactment, 1954, the Bandar Seri Begawan Municipal Board, with the approval of the Licensing Authority hereby makes the following rules :—

1. These rules may be cited as the Road Traffic (Bandar Seri Begawan Municipal Board) (Parking Places) (Amendment) Rules, 1983 and shall be read as one with the Road Traffic (Bandar Seri Begawan Municipal Board) (Parking Places) Rules, 1972 (hereinafter referred to as "the Principal Rules"). Citation.

2. Paragraph 2(1) of the Principal Rules is amended by inserting the following definitions in their appropriate alphabetical position : Amendment of paragraph 2(1).
 - "exemption pass" means an exemption pass issued by the Board under paragraph 16(d) showing the registration number of a motor vehicle and the period during which the said motor vehicle may be parked free of any parking charge in a specified reserved parking place as may be stated therein ;

 - "exemption period" means the period during which a parking place is designated as reserved parking place or the period during which a motor vehicle is authorised to be parked free of any parking charge in any specified reserved parking place ;

 - "reserved parking place" means a parking place described in columns 1 and 3 of the Schedule and so designated by written notice on one or more sign boards wherein may be parked only a motor vehicle in respect of which there is in force an exemption pass granted by the Board.

3. Paragraph 25 of the Principal Rules is amended by inserting after the words "half-hourly parking place" the following words : Amendment of paragraph 25.
 - "or reserved parking place".

4. Immediately after paragraph 29 of the Principal Rules the following new paragraph is inserted : Insertion of new paragraph.
 - "30. (1) The Board may designate any place or road or any part thereof as a reserved parking place by placing or erecting at or near such parking place a sign in accordance with Rule 25 of these Rules.

 - (2) No person shall park any motor vehicle in any reserved parking place except under and in accordance with the terms of an exemption pass issued by the Board in respect of such motor vehicle.

- (3) Any person using a reserved parking place shall display the exemption pass on the left side of the front wind-screen of the motor vehicle and where the vehicle is a motor cycle the exemption pass shall be displayed in a conspicuous position on the motor cycle."

Amendment of
Schedule.

5. The Schedule to the Principal Rules is hereby amended in the manner set out thereto —

(a) by inserting immediately after the matter relating to item 13 the following —

- (i) in column (2) the words "Not applicable" ;
- (ii) in column (3) the words "Reserved parking place" ;
- (iii) in column (4) the words "See Note A or B for outside exemption period" ;

(b) by inserting immediately after the matter relating to item 14 the following :—

- (i) in column (2) the words "Not applicable" ;
- (ii) in column (3) the words "Reserved parking place" ;
- (iii) in column (4) the words " See Note A or B for outside exemption period" ; and

(c) by inserting immediately after item 18 the following :—
