## CONSTITUTION OF BRUNEI DARUSSALAM (Order under section 83 (3))

# **EMERGENCY (STATUTORY FUNDS APPROPRIATION) (AMENDMENT) ORDER**, 1993

In exercise of the powers conferred upon him by sub-section (3) of Section 83 of the Constitution of Brunei Darussalam, His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam hereby makes the following Order -

The Order may be cited as the Emergency (Statutory Funds Appro-1. priation) (Amendment) Order, 1993.

2. Section 2 of the Statutory Funds Appropriation Act, 1959 (hereinafter referred to as the Principal Act) is hereby amended by deleting the words and figures "Five hundred and eighteen million five hundred and eighty thousand dollars (\$518,580,000.00)" and substituting the following words and figures in their place, that is to say "Seven hundred and forty-two million and six hundred and ten thousand dollars (\$742,610,000.00)".

3. The Schedule to the Principal Act is hereby repealed and the follow-Schedule. ing new Schedule is substituted therefor :-
