# LAW REVISION ACT (CHAPTER 1)

#### LAW REVISION ORDER NO. 1 OF 2000

In exercise of the powers conferred by subsections (1) and (2) of section 5 of the Law Revision Act, the Attorney General hereby makes the following Order —

#### Citation and commencement.

1. This Order may be cited as the Law Revision Order No. 1 of 2000 and shall be deemed to have commenced on the 31st. October, 2000.

#### Inclusion of pages.

2. The inclusion in the Laws of the pages specified in the third column of the First Schedule with reference to the written laws specified in the first and second columns thereof is hereby authorised.

#### Removal of pages.

3. The removal from the Laws of the pages specified in the third column of the Second Schedule with reference to the written laws specified in the first and second columns thereof is hereby directed.

#### Substitution of pages.

4. The removal from the Laws of the pages specified in the third column of Part A of the Third Schedule bearing on the face thereof or overleaf the legend specified in the fourth column thereof with reference to the written laws specified in the first and second columns thereof is hereby directed, and the inclusion in the Laws, in substitution of the pages so directed to be removed, of the pages specified in the third column of Part B of that Schedule bearing on the face thereof or overleaf the legend specified in the fourth column thereof with reference to the written laws specified in the first and second columns thereof is hereby authorised.
