**MISCELLANEOUS LICENCES ACT
(CHAPTER 127)**

MISCELLANEOUS LICENCES (AMENDMENT) REGULATIONS, 2008

In exercise of the power conferred by section 2(1) of the Miscellaneous Licences Act, the Minister of Home Affairs, with the approval of His Majesty the Sultan and Yang Di-Pertuan, hereby makes the following Regulations —

Citation.

1. These Regulations may be cited as the Miscellaneous Licences (Amendment) Regulations, 2008.

Insertion of new regulation 17A into Miscellaneous Licences Regulations.

2. The Miscellaneous Licences Regulations, in these Regulations referred to as the principal Regulations, are amended by inserting the following new regulation immediately after regulation 17 —

"Display and storage of food and goods in licensed places

Display and storage of food and goods.

17A. (1) A licensee shall separate the display and storage of such food and goods and in such manner, as the Chairman of the licensing authority may specify.

(2) A specification under subsection (1) may be general or limited to a particular, or a particular class of, food and goods."

Insertion of new regulations 42A and 42B.

3. The principal Regulations are amended by inserting the following new regulations immediately after regulation 42 —

"Display of notices.

42A. (1) A licensee shall, if so directed by the Chairman of the licensing authority, display such notices in such places, phrase them in such manner or cause them to be of such size, as the Chairman may consider fit.

(2) A licensee who contravenes or fails to comply with subsection (1) is guilty of an offence and liable on conviction to a fine not exceeding \$1,000 and, in the case of a continuing offence, to a further fine not exceeding \$100 for each day during which the offence continues.

Power to require food and goods for testing etc.

42B. (1) A licensee shall —

- (a) (i) supply free of charge to the Chairman of the licensing authority, any police officer or an authorised officer such samples of food and goods, of reasonable amount, as the Chairman, police officer or authorised officer may require for the purpose of testing, analysis or investigation; and
- (ii) remove from display and not offer for sale any food and goods, in respect of which samples have been supplied under sub-paragraph (i), during the period of such testing, analysis or investigation;

(b) produce to the Chairman of the licensing authority, any police officer or an authorised officer for inspection or for the purpose of obtaining copies or extracts of, or to provide him with copies or extracts of, any book, document or record that the Chairman, any police officer or an authorised officer may require and believes on reasonable grounds contains any information relevant to the administration or enforcement of these Regulations;

(c) furnish to the Chairman of the licensing authority, police officer or authorised officer such information as the Chairman, police officer or authorised officer may require in respect of those food and goods.

(2) A licensee who contravenes or fails to comply with subsection (1) is guilty of an offence and liable on conviction to a fine not exceeding \$1,000 and in the case of a continuing offence, to a further fine not exceeding \$100 for each day during which the offence continues."
