CONSTITUTION OF BRUNEI DARUSSALAM (Order made under Article 83(3))

CRIMINAL LAW (PREVENTIVE DETENTION) ACT (AMENDMENT) ORDER, 2012

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Criminal Law (Preventive Detention) Act [Amendment] Order, 2012.

Insertion of new section 1A into Chapter 150.

2. The Criminal Law (Preventive Detention) Act, in this Order referred to as the Act, is amended by inserting the following new section immediately after section 1—

"Interpretation.

1A. In this Act, unless the context otherwise requires —

"Bureau" means the Narcotics Control Bureau;

"Director of the Bureau", "Deputy Director of the Bureau" and "Assistant Director of the Bureau" mean, respectively, the Director, the Deputy Director and an Assistant Director of the Narcotics Control Bureau appointed under section 2A of the Misuse of Drugs Act [Chapter 27];

"Minister" means the Minister of Home Affairs;

"officer of the Bureau" has the same meaning assigned to it under the Misuse of Drugs Act (Chapter 27).".

Amendment of section 2.

- 3. The Act is amended -
 - (a) in section 2
 - (i) by deleting "(1)" from the first line;
 - (ii) in paragraph (b), by inserting "or the Bureau" immediately after "police" in the second and third lines;

(b) by repealing subsection (2).

Amendment of section 4.

4. Section 4 of the Act is amended, in subsection (1), by inserting "or the Bureau" immediately after "police" in the fourth line.

Amendment of section 5.

- 5. Section 5 of the Act is amended, in subsection (1) -
 - (a) by inserting "or the Bureau" immediately after "police" in the first line;
- (b) by inserting "or supervision by the Bureau" immediately after "supervision" in the fourth line;
- (c) in paragraph (b), by inserting "or officer of the Bureau" immediately after "Inspector";
- (d) in paragraph (c), by inserting "or officer of the Bureau" immediately after "Inspector";
- (e) in paragraph (d), by inserting "or officer of the Bureau in the district" immediately after "district";
- (f) in paragraph (e), by inserting "or the Bureau" immediately after "station":
- (g) in paragraph (f), by inserting "or officer of the Bureau in the district" immediately after "district" in the last line;

Amendment of section 6.

6. Section 6 of the Act is amended, in subsection (1), by inserting "or officer of the Bureau in the district" immediately after "district" in the third line.

Amendment of section 8.

7. Section 8 of the Act is amended, in subsection (1) by inserting "or an officer of the Bureau" immediately after "officer" in the first line.

Amendment of section 9.

8. Section 9 of the Act is amended, in subsection (2), by inserting "or an officer of the Bureau" immediately after "police" in the third line.

Amendment of section 16A.

9. Section 16A of the Act is amended by repealing subsection (6).
