CONSTITUTION OF BRUNEI DARUSSALAM (Order made under Article 83(3))

TABUNG AMANAH PEKERJA ACT (AMENDMENT) ORDER, 2014

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order –

Citation and commencement.

1. This Order may be cited as the Tabung Amanah Pekerja Act (Amendment) Order, 2014 and shall be deemed to have commenced on 12th October 2013.

Amendment of section 2 of Chapter 167.

2. Section 2 of the Tabung Amanah Pekerja Act, in this Order referred to as the Act, is amended by deleting the definition of "Board" and by substituting the following new definition therefor -

" "Board" means the Lembaga Tabung Amanah Pekerja established under section 3;".

Substitution of section 3.

3. The Act is amended by repealing section 3 and by substituting the following new section therefor -

"Establishment of Lembaga Tabung Amanah Pekerja.

3. There is hereby established a board known as the Lembaga Tabung Amanah Pekerja.".

Insertion of new section 3A.

4. The Act is amended by inserting the following new section immediately after section 3 -

"Appointment of Managing Director.

3A. His Majesty the Sultan and Yang Di-Pertuan shall appoint a Managing Director.".

Amendment of section 4.

5. Section 4 of the Act is amended -

(a) by deleting subsection (1) and by substituting the following new subsection therefor —

"(1) The Board shall consist of the following members -

- (a) a Chairman;
- (b) not more than two Deputy Chairmen;
- (c) Managing Director;

(d) such other persons of whom not less than five shall be representatives of the Government.";

(b) by deleting subsection (2) and by substituting the following new subsection therefor —

"(2) The members referred to in subsection 1(a), (b) and (d) shall be appointed by His Majesty the Sultan and Yang Di-Pertuan, notice of whose appointment shall be published in the *Gazette*.";

- (c) in subsection (5)
 - (i) by deleting "Deputy Chairman" from the second line and by substituting "Deputy Chairman" therefor;
 - (ii) in the proviso, by deleting "of the Fund" from the last two lines.
