CONSTITUTION OF BRUNEI DARUSSALAM (Order made under Article 83(3))

SUPPLEMENTAL CONTRIBUTORY PENSIONS (AMENDMENT) ORDER, 2014

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement.

1. This Order may be cited as the Supplemental Contributory Pensions (Amendment) Order, 2014 and shall be deemed to have commenced on 1st January 2012.

Amendment of section 2 of \$ 58/2009.

2. Section 2 of the Supplemental Contributory Pensions Order, 2009, in this Order referred to as the principal Order, is amended, in definition of "Board", by deleting "3(1)" from the last line and by substituting "3" therefor.

Substitution of section 3.

3. The principal Order is amended by repealing section 3 and by substituting the following new section therefor -

"Establishment of Supplemental Contributory Pensions Board.

3. There is hereby established a board known as the Supplemental Contributory Pensions Board.".

Insertion of new section 3A.

4. The principal Order is amended by inserting the following new section immediately after section 3-

"Appointment of Managing Director.

3A. His Majesty the Sultan and Yang Di-Pertuan shall appoint a Managing Director.".

Amendment section 4.

5. Section 4 of the principal Order is amended —

- $\langle a \rangle$ by deleting subsection (1) and by substituting the following new subsection therefor
 - "(1) The Board shall consist of the following members
 - (a) a Chairman;
 - (b) not more than two Deputy Chairmen;
 - (c) Managing Director;
 - (d) such other persons of whom not less than five shall be representatives of the Government.";
- (b) by deleting subsection (2) and by substituting the following new subsection therefor
 - "(2) The members referred to in subsection 1(a), (b) and (d) shall be appointed by His Majesty the Sultan and Yang Di-Pertuan, notice of whose appointment shall be published in the Gazette.";
- (c) in subsection (5), by deleting "chairman and deputy chairman" form the first line and by substituting "Chairman and Deputy Chairmen" therefor.
