INDUSTRIAL DESIGNS (AMENDMENT) ORDER, 2020

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement

1. This Order may be cited as the Industrial Designs (Amendment) Order, 2020 and shall be deemed to have commenced on 23rd April 2019.

Amendment of section 2 of S 7/2000

2. Section 2 of the Industrial Designs Order, 1999, in this Order referred to as the principal Order, is amended, in subsection (1), by deleting the definition of "Minister".

Amendment of section 7

3. Section 7 of the principal Order is amended, in subsection (1), by deleting "Minister" and by substituting "Attorney General" therefor.

Amendment of section 22

- 4. Section 22 of the principal Order is amended -
- (a) in subsection (1), by deleting "Minister" from the first line and by substituting "Attorney General" therefor;
- (b) in subsection (2), by deleting "Minister" from the first line and by substituting "Attorney General" therefor.

Amendment of section 36

5. Section 36 of the principal Order is amended, in subsection (3), by deleting "Minister" from the second line and by substituting "Attorney General" therefor.

Amendment of section 53
